Since the rights of creditors and third persons cannot be prejudiced by the entire absence of all record, as stated in the last section, such rights will not be destroyed by the neglect of the corporate officers to keep a proper record.63 As declared in a New Jersey case, the rights of creditors cannot be made to depend "upon the regularity with which the minutes of the city council are kept, nor whether they are kept at all."54 Thus, where the records are kept in an imperfect manner, and there is no written evidence in existence to prove that certain work was done by authority of the council, parol evidence will be admissible to prove that fact.65 So the passage and existence of an ordinance under which a contractor made large expenditures may be shown by parol testimony where the city fails to keep a record of its ordinances.56 So parol evidence is admissible to show 53.
